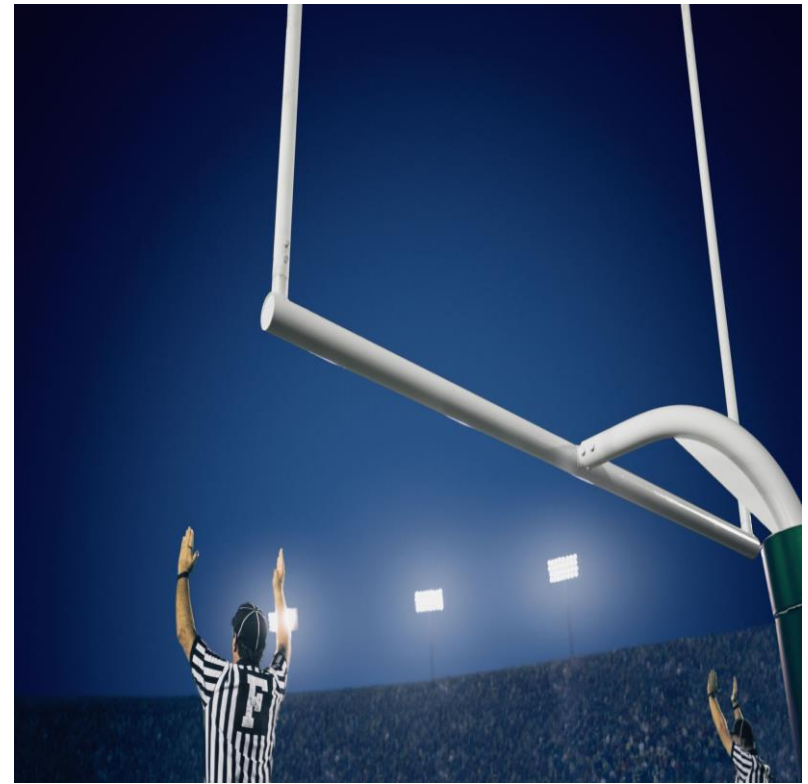
The School Improvement Process
